Our goal is to keep everyone informed and involved in our battle against Rio Tinto's lockout that's hurting families, communities, and businesses in the high desert. We can win by getting involved, staying united. Here's the latest news:

**Our families went to the British Consulate last Friday and had an incredibly successful event.**

If you didn't join more than 100 families who travelled together in a caravan of cars to the British Consulate last Friday, you missed a great event. Police estimated our numbers at 1000 strong. We told the Consulate that British companies like Rio Tinto aren't welcome in America if they hurt families, communities and local businesses like Rio Tinto is doing to us in the High Desert.

Besides the huge event in Los Angeles, there were also actions at the same time in front of other British Consulates in San Francisco, Seattle, Salt Lake City, Boston, and Vancouver, Canada.

Our events got positive news coverage in many cities, including Los Angeles where they ran great photos, plus good television and radio reports.

**In London and Australia, Local 30 members told Rio Tinto executives: end your cruel lockout now!**

Our own Dave Irish just returned from Rio Tinto's annual shareholder meeting in London where he spoke directly with CEO Tom Albanese. Dave explained to shareholders why Rio Tinto's lockout was cruel, unnecessary, and should end immediately. Travelling with Dave was ILWU International Vice President Ray Familathe, who also spoke with CEO Albanese, telling him that Rio's lockout in Boron is damaging the company's reputation with political leaders who make decisions that impact the company. Dave and Ray were both stranded for a few extra days because of the volcano in Iceland!

Rio Tinto had another shareholder meeting scheduled in Melbourne, Australia that Local 30 member Terri Judd flew to attend with ILWU International Secretary-Treasurer Willie Adams. After they arrived, the company postponed the meeting until May, but that didn't stop our team from going ahead with an action in front of Rio Tinto's headquarters. We got great support and assistance from the Maritime Union of Australia, the Miners Union, plus community groups including residents of Papua New Guinea who were mistreated by the company and continue to stand up for their rights. Residents are suing Rio Tinto in U.S. court right now for those past violations

Terri and Dave are both expected to attend our union meeting on Tuesday and will have a report for us about their trips to London and Melbourne.
